Terms & Conditions of the *Royal Oak Golf Club*

1. **Deposit:** A booking deposit of \$500 is required to secure the date of the event. This deposit also serves as a damage deposit. You will be held accountable for damage to property or equipment caused by any members of your event. Any costs associated with damage will be deducted from your deposit, and the remaining funds will be credited to the final bill.

2. **Cancellation Policy:** All cancellations must be submitted in writing. Events cancelled 30 days or more will receive a full refund of the deposit. Events cancelled less than 30 days in advance will forfeit their deposit.

3. **Confirmation:** A guaranteed number of guests are required 7 days prior to the event. You will be charged for the number confirmed unless there is an increase in the number of guests.

4. **Payment Terms:** Royal Oak Golf Club requires the host to pay 50% of the estimated cost 7 days prior to the event and the remaining balance payable on the day of the event. A credit card number will be held on file to process the balance of the bill. Alternate payment options are also available.

5. **Taxes & Gratuities:** 5% GST applies to food, beverages, and room charges. 10% provincial Liquor Tax applies to all alcoholic beverages. All food and beverages are subject to a 12% gratuity. Note; from July 1st 2010, 12% HST will replace the existing 5% GST and 7% PST.

6. **Food Policy:** Food and beverage including alcohol must not be brought on the premises of Royal Oak Golf Club. The only exception is a wedding cake. Due to health regulations, leftover food or beverages may not leave ROGC property.

7. **Liability:** In case of any violations of ROGC policy or Provincial Law, ROGC reserves the right to terminate services to any or all guests of the event. You will still be liable for all amounts owed to ROGC. ROGC assumes no responsibility for any damage or loss to goods, property, and equipment brought on the premises by any guests or the organizer.

8. **Music:** A SOCAN fee of \$43.19 with dancing or \$21.59 without dancing will be added to the final bill. A SOCAN(Society of Composers, Authors and Music Publishers of Canada) license is required when copyrighted music is performed in public.
